The Role

Maynooth University is committed to a strategy in which the primary University goals of excellent research and scholarship and outstanding education are interlinked and equally valued.

The Arts Council and Maynooth University invite applications from mid-career and established writers for Writer in Residence for the calendar year 2025.

The Arts Council Writer in Residence programme was established to provide a stimulating environment for the resident writer, as well as to afford a degree of financial support to concentrate on their own practice. Additionally, the residency brings energy and dynamism to the university, and allows students and faculty to engage with a practicing writer for a concentrated period.

Principal Duties

The Writer in Residence will be engaged for the calendar year 2025 and will be situated in the Department of English in Maynooth University, with the opportunity to engage with the wider campus.

The residency will be divided into two parts:

1. From January to June 2025 the Writer in Residence will be supported to engage with students and staff. This programme of engagement will be designed by the resident writer, in consultation with the faculty of the university, and could include focused teaching, workshops, mentoring, public events or other activities which bring new energy to the creative writing programme.
2. The writer in residence will contribute 2-4 hours per week to the MA in Creative Writing and will hold additional office hours. Contact time with staff and students will be capped at 4 hours per week. The writer will not be expected to deliver core curriculum.
3. From July onwards, the writer will be supported to concentrate his or her own practice.



Eligible Candidates

The residency is open to **mid-career and established writers** working in prose fiction, poetry, creative non-fiction, and children's fiction and poetry.

To be **eligible to apply**, applicants must:

- Be resident in the Republic of Ireland.
- Have a publishing track record in the areas of prose fiction, poetry, creative non-fiction, graphic novels and/or children's fiction and poetry. Applications from writers who have not published in these areas will not be considered. Writers working exclusively as playwrights are not eligible for this residency.
- **Be mid-career or established writers.** For the purpose of the Arts Council residency programme, mid-career and established is defined by the Arts Council as writers and illustrators with a demonstrable publishing track record, having published at least one full collection, novel or picture book with an independent, recognised publisher.
- The residency is only open to writers who have not undertaken an Arts Council/university residency in 2024. This is to ensure that a range of artists can avail of these unique opportunities.
- In line with the Public Sector Equality and Human Rights Duty, the Arts Council is committed to ensuring that it takes positive policy measures to promote equality of opportunity for all those living in Ireland, regardless of their gender, sexual orientation, civil or family status, religion, age, disability, race or membership of the Traveller Community. Furthermore, the Arts Council notes the ground of socioeconomic background as a further basis for which equality of opportunity must be guaranteed. The Arts Council therefore welcomes applications that are representative of the diversity of Irish society, including but not limited to any of the characteristics outlined above.

Making an Application

To make an application, writers should provide the following three documents:

1. A detailed proposal of 1-2 pages, which sets out how they would promise to engage with students, staff and the wider campus, and relevant experience to support this approach.
2. A one-page artist's statement, which describes how the residency could impact on the artist's practice.
3. A detailed CV, setting out artistic achievements and accomplishments. This should be no longer than 3 pages.

Assessment Process

Upon receipt of applications, the Arts Council and Maynooth University will determine the eligibility of applications.

Your application will be deemed ineligible, and will not go any further in the process, if any of the following is true:

1. You miss the application deadline.
2. You do not meet the eligibility requirements outlined above.



3. You do not submit the three required documents as outlined above.

Selection and Appointment

Following this, the Arts Council and Maynooth University will establish a selection committee, which will be made up of one representative from Maynooth University, one from the Arts Council and an external panellist with literary expertise. The selection committee will shortlist applicants based on the following criteria:

- artistic track record of applicant
- quality of idea/approach (referred to above), as outlined in the application, and the potential impact it could make on the relevant university department and university as a whole
- potential impact of residency on writer's own creative practice

A shortlist will be established (of no more than 4 writers).

- Only shortlisted candidates will be invited to attend for interview
- It is anticipated that interviews will be held in early December 2023
- Interviews will be held by video conference call
- Appointments will be approved by the President based on the report of the selection board
- The panel will make the final decision based on the above criteria and decisions will be communicated in December 2024
- The appointment is expected to be effective from 1 January 2025.

The entire fee will be paid to the writer directly by the Arts Council. It will be paid in two instalments, with a final report by the writer at the conclusion of the residency.

An Ról

Tá Ollscoil Mhá Nuad tiomanta do straitéis ina bhfuil spriocanna bunaidh sin na hOllscoile, barr feabhais sa taighde agus sa scoláireacht agus oideachas den chéad scoth, fite fuaite ina chéile agus an meas céanna orthu.

Cuireann an Chomhairle Ealaíon agus Ollscoil Mhá Nuad fáilte roimh iarratais ó scríbhneoirí atá i lár a ngairmréime agus scríbhneoirí aitheanta le haghaidh Scríbhneoir Cónaithe don bhliain féilire 2025.

Bunaíodh scéim Scríbhneoir Cónaithe na Comhairle Ealaíon chun timpeallacht spreagthach a chur ar fáil don scríbhneoir cónaithe, chomh maith le roinnt tacaíocht airgeadais a sholáthar dó le díriú ar chleachtas an scríbhneora féin. Anuas air sin, cuireann an chónaitheacht fuinneamh agus spleodar leis an ollscoil, agus tugtar deis do na mic léinn teagmháil a dhéanamh le scríbhneoir atá i mbun na ceirde ar feadh dlúth-thréimhse.

Príomhdhualgais

Fostófar an Scríbhneoir Cónaithe don bhliain féilire 2025, beidh sé lonnaithe i Scoil an Bhéarla in Ollscoil Mhá Nuad, agus beidh deis aige dul i ngleic le pobal an champais níos leithne.

Roinnfear an chónaitheacht ina dhá cuid:

2. Ó mhí Eanáir go mí an Mheithimh 2025, tacófar leis an Scríbhneoir Cónaithe chun dul i ngleic le mic léinn agus leis an bhfoireann ollscoile. Déanfaidh an scríbhneoir cónaitheach an clár rannpháirtíochta seo a dhearadh, i gcomhar le foireann na hollscoile, agus d'fhéadfadh go mbeadh teagasc dírithe, ceardlanna, meantóireacht, imeachtaí poiblí nó gníomhaíochtaí eile a chuireann fuinneamh nua leis an gclár scríbhneoireachta cruthaithí mar chuid den chlár sin.
4. Tabharfaidh an scríbhneoir cónaithe 2-4 uair sa tseachtain don MA sa Scríbhneoireacht Chruthaitheach, agus beidh uaireanta oifige breise aige. Is é ceithre uair an chloig in aghaidh na seachtaine an t-uasmhéid ama teagmhála a bheidh ag an scríbhneoir leis an bhfoireann



agus le mic léinn le linn an ama seo. Ní bheidh ar an scríbhneoir curaclam príomhúil a sheachadadh.

5. Ó mhí Iúil ar aghaidh, tacófar leis an scríbhneoir chun díriú ar a chleachtas féin.

Iarrthóirí Incháilithe

Tá an chónaitheacht oscailte do scríbhneoirí atá i **lár a ngairmréime agus scríbhneoirí aitheanta** atá ag obair i bhficsean próis, filíocht, neamhfhicsean cruthaitheach chomh maith le scríbhneoirí atá ag obair ar fhicsean agus filíocht do leanaí.

Le bheith i **dteideal iarratas a dhéanamh**, ní mór d'iarratasóirí:

- A bheith ina gcónaí i bPoblacht na hÉireann.
- Cuntas teiste san fhoilsitheoireacht a bheith acu sna réimsí seo a leanas: ficsean próis, filíocht, neamhfhicsean cruthaitheacht, úrscéalta grafacha agus/nó ficsean agus filíocht do leanaí. Ní ghlacfar le hiarratais ó scríbhneoirí nár foilsíodh sna réimsí sin. Níl scríbhneoirí a oibríonn mar dhrámadóirí amháin incháilithe don chónaitheacht seo.
- **A bheith mar scríbhneoirí atá i lár a ngairmréime nó atá aitheanta.** Chun críche chlár cónaitheachta na Comhairle Ealaíon, déanann an Chomhairle Ealaíon sainmhíniú ar i lár na gairmréime agus aitheanta mar scríbhneoirí a bhfuil cuntas teiste foilsitheoireachta soiléir acu, tar éis dóibh ar a laghad cnuasach iomlán amháin, úrscéal nó leabhar pictiúr a fhoilsiú le foilsitheoir neamhspleách, aitheanta.
- Níl an chónaitheacht oscailte ach amháin do scríbhneoirí nár thug faoi chónaitheacht na Comhairle Ealaíon/ollscoile in 2024. Déantar é seo chun deimhniú gur féidir le raon ealaíontóirí ceann de na deiseanna ar leith seo a fháil.
- De réir Dhualgas na hEarnála Poiblí um Chomhionannas agus Cearta an Duine, tá an Chomhairle Ealaíon tiomanta do chinntiú go dtugtar faoi bhearta beartais dhearfaigh chun comhionannas deiseanna a chur chun cinn do gach duine a chónaíonn in Éirinn, beag beann ar inscne, gnéaschlaonadh, stádas sibhialta nó teaghlaigh, creideamh, aois, míchumas, cine nó duine den Lucht Taistil. Ina theannta sin, tarraingíonn an Chomhairle Ealaíon aird ar an gcúlra socheacnamaíoch mar fhoras eile ina gcaithfear comhionannais deiseanna a chinntiú. Dá bhrí sin, cuireann an Chomhairle Ealaíon fáilte roimh iarratais ó gach cuid de shochaí na hÉireann, na tréithe thuasluaite ina measc ach nach bhfuil teoranta dóibh.

Conas Iarratas a Dhéanamh

Ba cheart do scríbhneoirí na trí cháipéis seo a leanas a chur ar fáil chun iarratas a dhéanamh:

4. Togra mionsonraithe de 1-2 leathanach ina leagtar amach conas a rachfaí i ngleic le mic léinn, leis an bhfoireann agus le pobal an champais níos leithne, mar aon le taithí ábhartha a thacaíonn leis an gcur chuige seo.
5. Ráiteas an ealaíontóra, ar aon leathanach amháin, ina ndéantar cur síos ar an tionchar a bheadh ag an gcónaitheacht ar chleachtas an ealaíontóra.
6. CV mionsonraithe, ina leagtar amach éachtaí agus gaiscí ealaíonta. Níor chóir go mbeadh an CV níos faide ná 3 leathanach.

An Próiseas Measúnaithe



Ar iarratais a fháil, déanfaidh an Chomhairle Ealaíon agus Ollscoil Mhá Nuad cinneadh ar cháilitheacht na n-iarratas.

Measfar go bhfuil d'iarratas neamh-incháilithe agus ní chuirfear é chun cinn go dtí an chéad chéim eile den phróiseas má bhaineann aon cheann de na rudaí seo a leanas leis:

4. Chuir tú an t-iarratas isteach i ndiaidh an spriocdháta.
5. Ní chomhlíonann tú na critéir cháilitheachta a leagtar amach thuas.
6. Ní chuireann tú na trí cháipéis riachtanacha isteach mar a leagtar amach thuas.

Roghnú agus Ceapadh

Ina dhiaidh sin, bunóidh an Chomhairle Ealaíon agus Ollscoil Mhá Nuad coiste roghnúcháin agus beidh ionadaí amháin ó Ollscoil Mhá Nuad, duine amháin ón gComhairle Ealaíon, agus comhalta painéil seachtrach ag a bhfuil saineolas liteartha ar an bpainéal sin. Cuirfidh an coiste roghnúcháin gearrliosta d'iarrthóirí le chéile bunaithe ar na critéir seo a leanas:

- cuntas teiste ealaíonta an iarratasóra
- caighdeán an smaoinimh/chur chuige (tagraítear don mhéid sin thuas), mar atá le sonrú san iarratas, agus an tionchar a d'fhéadfadh a bheith ar roinn ábhartha na hollscoile agus ar an ollscoil ar an iomlán.
- an tionchar féideartha a d'fhéadfadh a bheith ag an gcónaitheacht ar chleachtas cruthaitheachta an scríbhneora féin

Bunófar gearrliosta (ní bheidh níos mó ná ceathrar scríbhneoirí air).

- Ní thabharfar cuireadh ach d'iarrthóirí a chuirfear ar ghearrliosta freastal ar agallamh.
- Táthar ag súil go dtionólfar na hagallaimh ag tús mhí na Nollag 2023.
- Reáchtálfar na hagallaimh trí ghlaoch físchomhdhála.
- Ceadóidh an tUachtarán na ceapacháin bunaithe ar thuarascáil an bhoird roghnúcháin
- Déanfaidh an painéal an cinneadh deiridh bunaithe ar na critéir thuasluaite agus cuirfear cinní in iúl i mí na Nollag 2024.
- Táthar ag súil go dtiocfaidh an ceapachán i bhfeidhm ón 1 Eanáir 2025.

Dámh agus Institiúidí Taighde

Tá Dámh na nEalaíon, an Léinn Cheiltigh agus na Fealsúnachta comhdhéanta de Ranna na Sean-Chlasaicí, na Staire, an Cheoil, na Fealsúnachta, Scoil an Léinn Cheiltigh (Luath-Ghaeilge agus Nua-Ghaeilge), Scoil na Nuatheangacha, na Litríochtaí agus na gCultúr, agus Scoil na Nuatheangacha, na Litríochtaí agus na gCultúr (an tSínis, an Fhraincis, an Ghearmáinis agus an Spáinnis). Is é ról na Dámhe comhordú a dhéanamh ar ghníomhaíochtaí acadúla na ranna éagsúla, maoirseacht a dhéanamh ar fhorbairt straitéiseach na ranna agus tacú le cláir idir-rannacha. Tá roinnt institiúidí idirdhisciplíneacha ceaptha ag an Ollscoil chun tacú le taighde den scoth agus chun cumas taighde a fhorbairt sna disciplíní ar fad. Is é ról na Dámhe comhordú a dhéanamh ar ghníomhaíochtaí acadúla na ranna éagsúla, maoirseacht a dhéanamh ar fhorbairt straitéiseach na ranna agus tacú le cláir idir-rannacha. Tá roinnt institiúidí idirdhisciplíneacha ceaptha ag an Ollscoil chun tacú le taighde den scoth agus chun cumas taighde a fhorbairt sna disciplíní ar fad, lena n-áirítear Institiúid na nEalaíon agus na nDaonnachtaí.

An Roinn



Tá sé bhall foirne déag lánaimseartha ag Roinn an Bhéarla Ollscoil Mhá Nuad agus cuireann sí cúrsaí fochéime agus iarchéime ar fáil bunaithe ar a láidreachtaí taighde atá aitheanta go hidirnáisiúnta i litríocht an Bhéarlóra agus i litríochtaí eile ó thréimhse na nua-aoise luaithe go dtí an lá atá inniu ann. Tá an staidéar ar litríochtaí an Bhéarlóra thar thréimhse na nua-aoise luaithe agus nua-aoise chun tosaigh i misean na Roinne le fada an lá. Tá sé mar aidhm againn eispéireas foghlama spreagúil agus tairbheach a chur ar fáil dár mic léinn. Tá ár léachtóirí atá aitheanta go hidirnáisiúnta tiomanta chun ligean do mhic léinn a gcumas iomlán a bhaint amach mar léitheoirí, scríbhneoirí, agus criticí, agus mar shaoránaigh de dhomhan casta. Tá ár sraith fhairsing de chroí-mhodúil agus de mhodúil roghnacha i litríochtaí an Bhéarla agus an Bhéarlóra ag leibhéal BA curtha le chéile go cúramach chun eolas, inniúlachtaí agus dúshláin an disciplín chomh maith le scileanna tábhachtacha inaistrithe a chur ar fáil d'fhoghlaimoirí. Ag leibhéal iarchéime, cuireann an Roinn clár MA múinte ar fáil, "Literatures of Engagement", atá tiomanta d'áit na litríochta sa domhan a fhiosrú, clár MA mhúinte sa Scríbhneoireacht Chruthaitheach, chomh maith le clár PhD struchtúrtha.

An Ollscoil

Is ollscoil faoi leith í Ollscoil Mhá Nuad, institiúid choláisteach atá dírithe ar an eolaíocht agus ar an innealtóireacht, ar na daonnachtaí agus ar na heolaíochtaí sóisialta, agus chomh tiomanta céanna don taighde, don teagasc agus do rannpháirtíocht sa phobal. Suite san aon bhaile ollscoile in Éirinn, cuireann stair agus oidhreacht uathúil an bhaile go mór le carachtar agus le féiniúlacht na hinstitiúide. Cuirtear oideachas ar ardchaighdeán ar fáil do bhreis is 13,500 mac léinn ar an gcampas, áit a bhfuil fréamhacha an 18ú haois agus fuinneamh an 21ú haois araon ag baint léi.

Ó bunaíodh Ollscoil Mhá Nuad mar ollscoil phoiblí neamhspleách 25 bliain ó shin, tá forbairt shuntasach straitéiseach agus éachtaí as cuimse déanta aici, rud atá ina údar iontach mórtais ag baill foirne, ag mic léinn, ag céimithe agus ag pobal na hOllscoile araon. Aithnítear Ollscoil Mhá Nuad anois i measc na bpríomhollscoileanna óga is fearr ar domhan, agus í sa chéad áit sa liosta is déanaí de 'na hOllscoileanna Óga is Fearr' sa bhliain 2022, atá foilsithe ag Times Higher Education (THE). Tá an deacháil atá ar Ollscoil Mhá Nuad ar fud an domhain bunaithe ar an nuálaíocht, an caighdeán, an tábhacht agus tionchar a cuid taighde agus scoláireachta, an tiomantas don oideachas agus don fhoghlaim, caighdeán na gclár acadúil, agus an cheannaireacht atá léirithe aici chun an rannpháirtíocht san ardoideachas a leathnú. Is iad tiomantas na mball foirne agus fuinneamh agus rannpháirtíocht na mac léinn is cúis leis an rath seo atá ar an Ollscoil.

Is áit í Ollscoil Mhá Nuad a bhfuil roinnt codarsnachtaí ag baint léi - institiúid nua-aimseartha, dhinimiciúil atá ag fás go tapa agus í dírithe ar an taighde agus í rannpháirteach, ach tá sí fréamhaithe freisin sna buanna acadúla agus sna traidisiúin léinn. Cuireann an Ollscoil réimse leathan clár fochéime, iarchéime agus dochtúireachta ar fáil do bhreis is 15,000 mac léinn sna daonnachtaí, san eolaíocht agus innealtóireacht, sna heolaíochtaí sóisialta, lena n-áirítear an gnó, an dlí agus an t-oideachas. Cuireann an Ollscoil réimse leathan de chlár agus de chomhpháirtíochtaí idirnáisiúnta ar fáil chomh maith.
