This is to confirm that you will be Artist in Residency at An Grianán Theatre from [DATE] until [DATE]. This 9-month residency has been made possible through dedicated funding from Peace III.

The residency will include a retrospective of your work focussing on three shows in particular. The shows will be performed at An Grianán as follows:

The Derry Boat – Week Beginning 11 October 2010

The Mental – Week Beginning 10 January 2011

Rural Electric – Week Beginning 7 March 2011

Each play includes the performance week and a prior week of rehearsal with the other necessary production personnel. In addition to the performances at An Grianán, there will also be performances of The Derry Boat and Rural Electric at our partner theatres, The Alley in Strabane and The Waterside Theatre in Derry. The residency will also involve 24 workshops with different community groups, a publication including the text of the plays as well as an exhibition, which will be curated by the County Museum.
